**Reports from Current Governing Board Members:** Mark Snell, Karl Helgevold and Phil Clifton will no longer be on the board as of December 31, 2024.

### Staff Update:

- It is still ok for counties to pay for substance use services.
- The state has changed case load requirements for MCOS to require a cap of 45, which we anticipate will lead to job openings at the MCOs that CICS may apply for.
- The Story County office has moved to: This is a one-year lease with the option for two 2-year extensions.

### Realignment

Legislation has been signed to combine substance use disorders and mental health under behavioral health and initiate a procurement process for entities to apply to be Behavioral Health Administrative Service Organizations within geographic areas defined as Districts. The district map will be final by August 1<sup>st</sup>. CICS has submitted input to HHS based on empirical data and will be working with the new draft maps (new drafts are based on AAAs and Community Action Agencies) that were recently released to do another comparison.

Additionally, Aging and Disability services have been combined and will undergo a similar procurement process for entities to apply to be Disability Access Points.

December 31, 2024 has been legislatively designated as the date by which HHS must designate Behavioral Health Administrative Service Organizations. The Disability Access Points may be announced sooner.

Russell has been in communication with other regions and Elderbridge regarding the realignment.

When the MHDS regions go away, that does not necessarily mean that CICS does, as the entity can do other work.
